The CWBA's Annual Business Meeting will be held at the 39th Annual CWBA Convention on Saturday, May 21, 2016, 6:30 p.m. at The Sebastian Hotel in Vail, Colorado. At that time, the 2016-2017 CWBA Board of Directors will be elected.
