## President's Letter: by Patricia M. Jarzobski Professionalism and Helping Others - It's Our Oath

**D**o you remember this:

"I will treat all persons whom I encounter through my practice of law with fairness, courtesy, respect and honesty; I will use my knowledge of the law for the betterment of society and the improvement of the legal system; I will never reject, from any consideration personal to myself, the cause of the defenseless or oppressed . . ."

It is the Colorado oath of admission for attorneys.

Colorado Supreme Court Chief Justice Michael Bender and Past CBA President David Masters have declared October 2012 Legal Professionalism Month in Colorado.

Why?

"[T]he civil justice system is at a crossroads and that, as a result, we all have new opportunities and old responsibilities. Four years ago, concerns about skyrocketing costs, unprofessional gamesmanship, and long delays in civil litigation were the stuff of grousing and shoulder shrugs. We all had a level of fatalism or cynicism about our inability to change any of those factors. Now, that is not true. There is a window of opportunity that has opened—a convergence of various forces resulting in a willingness of decision-makers to consider change."

In 2011, Chief Justice Bender brought together the bar, the judiciary, and the law schools and established the Chief Justice's Commission on the Legal Profession.

The CWBA is a member of the Chief Justice's Commission.

Chief Justice Bender asked the bar associations to help take the lead in better addressing the needs of the legal profession and our community as a whole by:

- ▶ Promoting professionalism;
- ▶ Improving public attitudes toward the profession through a renewed dedication to *pro bono* service; and
- ▶ Increasing the training of and support for law students and new lawyers.

When the Chief Justice asks, we say yes!

There is a funding crisis in our community in providing legal services to low-income families. This crisis primarily affects women. The CWBA is authoring a special issue of *The Colorado Lawyer* in October 2012, which includes an article describing how women are disproportionately affected by cuts in

legal aid funding and highlighting options to address these funding shortages.

The CWBA's legal services committee is re-dedicated to providing actual legal services to those in need. The CWBA is partnering with the Colorado Lawyer's Committee's Legal Nights at Centro San Juan Diego to provide legal information and referrals for individuals and families who cannot afford legal services.

The CWBA's membership committee is hosting the summer membership social that will include a silent auction to raise funds for Colorado wildfire victims on July 30, 2012 at Second Home.

Some bar leaders describe the need for mentoring lawyers today as an emergency. The CWBA will continue to build supportive relationships between the different generations of lawyers and to provide a positive place where women can learn leadership skills. This fall, the CWBA's professional advancement committee will resume its successful program on self-promotion skills for attorneys.

During October's Legal Professionalism month, the CWBA is collaborating with the other specialty bar associations to hold a low-cost program called "Diversity in Colorado: Where We've Been, Where We Are, and Where We Need to Go."

# 35th Annual CWBA Convention: “When Push Comes to Shove: Grace Under Pressure”

The 35th Annual CWBA Convention, “When Push Comes to Shove: Grace Under Pressure,” took place June 8-10, 2012 at the Vail Marriott Mountain Resort & Spa. Attendees were treated to perfect weather and a weekend of education, entertainment, and celebrations.

On Friday afternoon, the outgoing and incoming CWBA Board members enjoyed a Leadership Summit highlighted by the presence of many past CWBA presidents, and members of the CWBA Foundation Board. Nationally recognized jury consultant and NITA trainer Mary Ryan presented focus group research compiled over more than 20 years to help trial lawyers present and try cases more effectively. The CLE panels included discussions on mock trials, keeping workplaces drama-free, mediation, women who run their own law firms, ethics and technology, and strategies for effectively handling media pressure.

# Public Policy: Highlights of the 2012 Legislative Session

The 2012 session was productive with over 630 bills, resolutions and memorials introduced and debated. While many failed to move out of the opposite chamber due to political divides, many pieces of solid bi-partisan legislation did pass and will become law. As with previous years, the state budget commanded much attention throughout the session. However, economic forecasts proved to be more optimistic than originally expected and the FY 12/13 budget fared better than previous years.

## 2012 Legislation of Interest

### **HB 12-1139: Pretrial Detention of Children Tried as Adults** (Rep. Levy/Senator Guzman)

HB 12-1139 changes the presumption in current law that juveniles who are charged as adults (a process known as direct filing) be detained pending a trial in an adult jail facility. Under the bill, such juvenile defendants are required to be held in a juvenile facility unless a judge determines, after a hearing, that the appropriate place of confinement is an adult jail. The bill gained widespread bi-partisan support and easily passed through both houses, unlike its companion bill HB 12-1271. *CWBA supported the bill by lending the organization's name to the fact sheet and communicating with both sponsors CWBA's level of support.*

### **HB 12-1151: Human Trafficking and Prostitution** (Rep. McCann/Senator S. King)

HB 12-1151 strengthens the state's laws surrounding human trafficking, specifically regarding individuals convicted of trafficking in adults, trafficking in children, or coercion of involuntary servitude. *CWBA's public policy committee was asked to review and support this measure via one of its members. Learning that the bill had broad and deep support, CWBA directed its lobby team to monitor the bill through the process.*

### **HB 12-1256: Formula for Maintenance of Marriage Dissolution** (Rep. McCann/Senator Mitchell)

HB 12-1256 creates a presumption that maintenance will be awarded to one of the parties in a dissolution of marriage action filed on or after July 1, 2012, and provides a formula for the presumptive award in cases where the parties meet certain income and duration of marriage criteria. *CWBA members discussed the proposal at length as members had differing viewpoints on the construction of the formula. At the request of the sponsor, Rep. McCann, the bill was postponed indefinitely and an interim work group was formed to discuss the issue for potential 2013 legislation. CWBA will be represented by Theresa Spahn and Lucy Denson on the*

*work group, which is slated to begin work in mid-summer. This work group will be joined by designees from the CBA, AAML, Rep. McCann, CPA- member and the bill's proponents (Gina Weitzenkorn, Denise Mills, Helen Shreves and Mercedes Aponte).*

### **HB 12-1271: Juvenile Direct File Limitations** (Reps. McCann and Nikkel/Senators Giron and Neville)

HB 12-1271 raises the minimum age for direct filing to 16. Additionally, it limits the offenses for which a juvenile can be direct filed to class 1 or 2 felonies, violent sex offenses, and crimes of violence committed by prior violent juvenile offenders. Perhaps the most contentious element of the bill and most vigorously opposed by the District Attorneys, is the creation of a pre-trial "reverse transfer" hearing presided over by a judge. The bill faced stiff opposition from the DA's and Attorney General, and received considerable attention from the media. Ultimately the bill passed with bi-partisan support and the Governor signed the bill into law, despite intense lobbying to veto. *CWBA supported the bill throughout the process and provided lobbying assistance in both the House and Senate. In addition, the CWBA submitted a letter of support to Governor Hickenlooper urging his signature on this bill.*

### **SB 12-15: Optional Category of Tuition** (Senators Giron and Johnston/Rep. Duran)

SB 12-15 authorizes the creation of an optional category of tuition at public institutions of higher education for Colorado's undocumented students. The new tuition category, called standard rate tuition, is applicable to undocumented students who have been enrolled in a Colorado high school for at least three years, have graduated or obtained a GED, and who are currently pursuing citizenship. Partisan politics played into the vote in the House Finance Committee, and the bill failed to move forward. *CWBA supported the bill throughout the process and provided lobbying assistance in both the House and Senate.*

### **SM 12-003: Respect for Rights of Conscience Act of 2011** (Senator Neville/ None)

SM 12-003 called upon Congress to enact the "Respect for Rights of Conscience Act of 2011" and encourage President Obama to provide a religious conscience exemption to the requirements to cover certain health care services that conflict with religious beliefs. The memorial, merely a symbolic proposal with no force of law, was fiercely opposed by

the Senate Democrats who passed it out of the Senate Health Committee in order to have a recorded debate on the floor. Conversely, the Senate Republicans also felt strongly about the memorial and locked down for a three-hour plus debate. The CWBA Board voted to oppose the memorial at the request of partner organizations, and lent its name to a letter of opposition.

## **Looking Forward**

The remainder of 2012 is shaping up to be a busy year politically in Colorado. In June, the Joint Budget Committee will convene to receive the quarterly economic forecast, which will likely close out the FY 11/12 budget with a transfer of excess revenue to the State Education Fund. Additionally, several interim committees will be meeting during the coming months. Ongoing committees include the Health Benefit Exchange Implementation Review Committee, Transportation Legislation Review Committee and the Water Resources Review Committee, and a non-funded study that will review the need for mandatory elder abuse statutes, amongst others. In addition, this year a committee was authorized to study Colorado's Enterprise Zone Designations and make legislative recommendations for the 2013 session.

Colorado voters will have many choices ahead of them as we enter the June primaries and November general election. Legislators will begin campaigning in earnest after the special session has concluded, as they race to raise money and campaign in their districts. The 2012 election will feature new district boundaries, and in some cases new districts as set forth in December 2011 by the formal redistricting and reapportionment process. Tempers are still high among some legislators who were pushed out of their districts or forced into primaries with their colleagues, and this election cycle will prove to be hyper-partisan. Primaries are held this year on June 23rd across the state. Many of these races actually determine the winner in the general election because of the voter registration composition in the districts.

In November, all 65 House districts are up for election, as well as roughly half of the Senate districts. As Colorado is a swing state in the Presidential election, we expect some down ticket repercussions of the national campaigns. Additionally, voters will have several ballot initiatives to weigh in on. To date, only one issue has been certified for the ballot, legalization of marijuana, however many others have titles and are gathering signatures for approval. As the deadline for the 2012 election gets closer, we will prepare a comprehensive report of the pending ballot initiatives and

resources for interested voters.

As always, thank you for the honor of representing your issues at the State Capitol, and we look forward to a continued partnership. ♦
